#### Overview and staffing update

The College Procurement function is currently working towards refreshing all the procurement procedures, processes and templates and will be delivering training to all staff in due course. A session on the updated procurement thresholds and procedures was delivered at the recent Staff Development Day and this will be repeated at a forthcoming College Leadership Team meeting.

At present, the College has a contract with APUC for a 0.5FTE procurement professional. With the additional work identified, including a review of all contracts, this was extended temporarily to 0.8FTE. The College has also had additional support from APUC over the past year but both APUC and the College have identified that there is a requirement for a solution that allows the Supply Chain Manager to concentrate on major contracts and the development of procurement processes internally. To that end, it has been agreed to look to APUC to provide a further secondment for a period of up to one year as part of a project to bring the College up to date in terms of contracts and the establishment of an online procurement resource.

## **Procurement Reporting**

The College is not formally required to produce an Annual Report due to its level of spend being below the appropriate threshold, but it does do so as a demonstration of good practice. The Report for the period 1<sup>st</sup> August 2020 – 31<sup>st</sup> July 2021 will be presented to the Finance and Resources Committee in April 2022.

#### **Sustainability/ Carbon Reduction**

Sustainability continues to be a key focus in Procurement and opportunities to build sustainability into each contract will continue to be considered.

Procurement will ensure that we build carbon reduction into the tendering process. It is recognised that it is important to adjust working practices to enable us to reduce the carbon footprint, to have targets for reducing indirect emissions of greenhouse gases and to report on how we will align spending and use of resources with emissions reduction efforts.

The College function is also looking at what is termed "circular procurement" which sets out an approach to green public procurement. This includes paying special attention to "the purchase of works, goods or services that seek to contribute to the closed energy and materials loops with the supply chains, whilst minimising, and in the best case avoiding, negative environmental impacts and waste creation across the whole life-cycle" This will be embedded into the procurement policy and processes. For example: potentially leasing rather than owning vehicles.

The Supply Chain Manager attends the Sustainability Group to obtain information on anything that could be included in future procurement activities and to advise on opportunities for Community Benefit.

### Policy and Procedures & SLC Procurement Toolkit

The Procurement Thresholds and the Procurement Initiation form have now been approved (see Finance and Resources Committee ref. 08-22 for the former) and will be accessible to all SLC Staff.

Procurement is currently reviewing all policy and procedures and given them a refresh, these are being uploaded onto SharePoint – SLC Finance- SLC Procurement Toolkit.

The Procurement Toolkit will be a portal that holds all policy, procedures, and guidance for procurement activities. This includes – Thresholds for procurement, Maps of the Process, Procurement Templates, and Process guidance, this will provide all the tools required to procure compliantly.

This will also link to the SLC Contract register and APUC Framework Agreement Library this will enable the staff to locate Framework Agreements that are available within their field of expertise.
